DIRECTIONS FOR USE: GENERAL CLEANING

EGR is used as a “ready to use” product. Depending of the nature and thickness of the contamination, use in a spray, bucket and brush application or cleaning unit. To apply, add **EGR Extra** to the surface to be cleaned. Allow some time (2- to -15 minutes) for **EGR Extra** to take effect, and remove dirt by hard brush-in or by high pressure application. **EGR Extra** leaves an anti-corrosion film. When a surface has been treated, rinse with water. Increasing temperature (up to 50 C°) speeds up the cleaning-time and cleaning activity. Cleaning equipment units are available in different sizes and also in a warm version. Product information is available upon request. **EGR Extra** can be safely be used with all methods of cleaning: circulation cleaning, manual cleaning, etc.
